Consequently the Issued, Subscribed and paid-up share capital of the Company stands increased to Rs 27,40,44,000/- divided into 2,74,04,400 equity shares of the face value of Rs. 10/- each From Rs. 18,26,96,000/- divided into 1,82,69,600 equity shares of the face value of Rs. 10/- each.
